through the famous Camp Pendleton
Marine base. Arrive & explore the
historic Mission San Juan Capistrano,
established more than two hundred years

ago. Famous for the Annual Return of the Swallows, the mission is the "Jewel of the California Missions." This afternoon travel by motorcoach south along the famous beaches of San Diego and pass by Torrey Pines Golf Course. Then stop in picturesque La Jolla for leisure time to wander, shop or maybe visit the famous La Jolla Cove. The late afternoon and evening are at your leisure to enjoy San Diego.
